SECTION 2. The Board of Directors of the Rock Township Ambulance District hereby adopt the attached Policy and Procedure Manual which is marked as Exhibit A as the Policy and Procedure Manual of the Rock Township Ambulance District.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage.

AN ORDINANCE OF THE ROCK TOWNSHIP AMBULANCE DISTRICT, MISSOURI APPROVING THE CONTRACT BETWEEN THE ROCK TOWNSHIP AMBULANCE DISTRICT AND INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS, LOCAL #2665 EFFECTIVE JANUARY 1, 2018
WHEREAS, the Board of Directors of the Rock Township Ambulance District have previously entered into a Collective Bargaining Agreement with the International Association of Fire Fighters (IAFF) Local #2665; and
WHEREAS, the Board of Directors has determined that it is in the best interest of the administration of the Rock Township Ambulance District to revise and update said agreement.
NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF ROCK TOWNSHIP AMBULANCE DISTRICT, AS FOLLOWS:
SECTION 1. The Chief of the Rock Township Ambulance District shall have the authority to sign the Collective Bargaining Agreement between the Rock Township Ambulance District and the International Association of Fire Fighters, Local #2665 on behalf of the Rock Township Ambulance District. A copy of the Collective Bargaining Agreement is attached to this ordinance as Exhibit A.
